APPROVING RESOLUTION NO. 211, S-2020 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED “APPROVING THE AMENDMENT TO THE ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2020 OF THE MUNICIPALITY OF LINGAYEN AS EMBODIED UNDER MDC RESOLUTION NO. 3, S-2020”

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Resolution No. 211, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Lingayen, Pangasinan amended their Annual Investment Program for CY 2020 to include change of location of one project in the previously approved AIP 2020 of the municipality from: *Construction of RHU-I Building and Building Facility @Avenida Rizal Street, Barangay Poblacion, Lingayen* to: *Construction of RHU-I Building and Building Facility @ Avenida Rizal Street West, Barangay Poblacion, Lingayen*;

WHEREAS, this was endorsed by the Local Development Council to the Sangguniang Bayan on June 4, 2020 thru MDC Executive Committee Resolution No. 03, Series of 2020 and was favorably acted upon by the Sangguniang Bayan on June 15, 2020 thru SB Resolution No. 211, S-2020. This is in accordance with Sections 106,109 and 114 of RA 7160;
