APPROVING RESOLUTION NO. 55, S-2021 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 3 FOR CY-2021 OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN AMOUNTING TO P1,972,061.31 FROM THE GENERAL FUND AND P87,442.09 FROM THE ECONOMIC ENTERPRISE"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its SB Resolution No. 55, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of San Fabian, Pangasinan prepared the LGU's Supplemental Investment Program No. 3 for CY 2021 which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 08, S-2021 dated April 29, 2021;

**WHEREAS**, said Supplemental AIP which has a total investment requirement of P2,059,503.40 covers augmentation funds for the Personal Services intended for the salaries and other benefits of newly-created positions from October 2021-December 2021, and granting of Performance-Based Bonus (PBB) to qualified personnel;

**WHEREAS,** funding for Supplemental AIP No. 3 is embodied in the LGU's Supplemental Budget No. 2 for CY 2021 which is enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2, S-2021 dated June 2, 2021;
