## **RESOLUTION NO. 653-2021**

DECLARING MUNICIPAL ORDINANCE NO. 3, S-2021 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE MORAL RECOVERY PROGRAM (MRP) IN THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Municipal Ordinance No. 3, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) of RA 7160; Article II, Section 21 of the 1987 Philippine Constitution; Proclamation No. 62 dated September 30, 1992 and Executive Order No. 319, entitled "Institutionalizing the Moral Recovery Program in All Government Departments, Offices, Agencies and Government-Owned and Controlled Corporations Through the Establishment of Integrity Circles";
