RESOLUTION NO. 657-2020

DECLARING MUNICIPAL ORDINANCE NO. 2020-03 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY USE OF FACE MASK AND STRINGENT PRACTICE OF PHYSICAL DISTANCING WITHIN THE MUNICIPALITY OF BALUNGAO, PANGASINAN DURING THE ENHANCED COMMUNITY QUARANTINE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2020-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (5) (xii) of RA 7160; Presidential Proclamation Nos. 922 and 929, both Series of 2020,; DILG Memorandum Circular No. 2020-062; Provincial Ordinance No. 235-2020 of the Sangguniang Panlalawigan of Pangasinan; and the Omnibus Guidelines on the Implementation of the Community Quarantine in the Philippines;

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer in her opinion dated June 20, 2020;

WHEREAS, subject ordinance shall take effect after the requirement of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;
