APPROVING RESOLUTION NO. 22, S-2019 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “APPROVING THE ANNUAL LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (LDRRMFIP) FOR CALENDAR YEAR 2020 IN THE AMOUNT OF TEN MILLION TWO HUNDRED ELEVEN THOUSAND SIX HUNDRED EIGHTY FIVE PESOS (P10,211,685.00) OF THE MUNICIPALITY OF VILLASIS, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 22, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said resolution and found out that the Annual Local Disaster Risk Reduction and Management Fund Investment Plan for CY 2020 was adopted and endorsed to the Sangguniang Bayan for approval through MDRRMC Resolution No. 01-2019 dated August 15, 2019. This was favorably acted upon by the Sangguniang Bayan through Resolution No. 22, S-2019 dated September 9, 2019;

WHEREAS, the programs, projects and activities to be funded from the 70% of the 5% LDRRM Fund (P10,211,585.00) amounting to P7,148,109.00 and the 30% lump sum Quick Response Fund amounting to P3,036,476.00 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum
