STRONGLY ENDORSING THE CONDUCT OF A FEASIBILITY STUDY ON THE ESTABLISHMENT OF A PROPOSED PROVINCIAL PRINTING PRESS TO SUPPORT THE NEW NORMAL CONTINUITY LEARNING PROGRAM-MODULAR LEARNING APPROACH FOR PANGASINAN

WHEREAS, the Sangguniang Panlalawigan recognizes the importance of conducting a feasibility study for the establishment of a proposed provincial printing press to support one of the distance learning modalities presented to the Body by the Department of Education Schools Divisions in the Province of Pangasinan;

WHEREAS, the Sangguniang Panlalawigan, during its inquiry held on July 6, 2020 Regular Session, has learned that Modular Learning Approach is the most preferred distance learning modality by learners in the Province of Pangasinan for School Year 2020-2021;

WHEREAS, in Modular Learning Approach, printing would remain to play an important role in the production and reproduction of teaching and learning materials and tools needed in the dissemination of knowledge between and among the learners and the teaching staff;

WHEREAS, a printing press would therefore be a relevant traditional instrument in the promotion of education by the Province of Pangasinan as it would go hand in hand with the objective of Modular Learning Approach;

WHEREAS, education is keeping alive printing and it is necessary therefore for the Province to conduct a feasibility study for the proposed establishment of a provincial printing press;




