AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN


WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to acquire said vehicle as a means to further enhance the services needed by the people;

NOW, THEREFORE, on motion of SP Members Angel M. Baniqued, Jr., duly seconded, it was –


