
**WHEREAS**, one of the main thrusts of the provincial government is to support the smooth implementation of lower local government units' program through countryside development;

**NOW THEREFORE**, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza, duly seconded, it was -


