DECLARING MUNICIPAL ORDINANCE NO. 2019-02 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITIONS OF ACCOUNTANT II, SG-15 UNDER THE MUNICIPAL ACCOUNTING OFFICE AND SANITATION INSPECTOR III, SG-11 UNDER THE RURAL HEALTH UNIT" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Municipal Ordinance No. 2019-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 76 and Section 447 (a) (1) (viii) of RA 7160;

WHEREAS, the salary grade of allocation of Accountant II should be adjusted from SG-15 to SG-16 pursuant to Budget Circular No. 2019-92 dated September 3, 2019. This position is one of the reallocated positions under said Circular;

WHEREAS, the qualifications of Sanitation Inspector III, SG 11 should be changed as follows:
