APPROVING RESOLUTION NO. 2019-090 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM FOR THE CALENDAR YEAR 2020 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2019-090 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has formulated the municipality’s Annual Investment Program for CY 2020 and endorsed thru MDC Resolution No. 2019-05 dated September 2, 2019 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 2019-090 dated September 25, 2019. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Balungao, Pangasinan was formulated following the prescribed AIP Summary

Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary requirements for the operation of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes the following: 1) Gender and Development Plan, Peace and Order Plan, Local Climate Change Action Plan, Nutrition Action Plan, Annual Procurement Plan and Annual Cultural Development Plan and 2) list of programs/projects for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities and to combat HIV-AIDS;

WHEREAS, the AIP has a total investment requirement amounting to P124,683,738.31. Of this, P113,060,738.31 will be funded from the municipality's proposed 2020 Annual Budget which was passed and approved by their Sangguniang Bayan on September 25, 2019 through Appropriation Ordinance No. 2019-01 and approved by the Municipal Mayor on October 4, 2019. The remaining amount of P11,623,000.00 is proposed to be funded by external sources (national government agency under Assistance to Municipalities Program);

WHEREAS, the development fund amounting to P19,196,810.60 which is allocated for development projects is twenty percent (20%) of municipality's IRA (P95,984,053.00) for CY 2020. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs, projects and activities to be funded by the 5% LDRRM Fund amounting to P5,081,852.65 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRMF Plan of the municipality was reviewed and a Certification was issued by the Office of the Civil Defense (OCD) dated January 15, 2019;

WHEREAS, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
