PROVINCIAL RESOLUTION NO. 67-2022

INVITING THE PROVINCIAL HEALTH OFFICER, PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER AND THE PROVINCIAL DIRECTOR OF THE PHILIPPINE NATIONAL POLICE OF THE PROVINCIAL INTER-AGENCY TASK FORCE (IATF); AND THE PRESIDENT OF THE LEAGUE OF MUNICIPALITIES OF THE PHILIPPINES-PANGASINAN CHAPTER TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS REGULAR (PHYSICAL) SESSION TO UPDATE THE BODY ON THE STATUS OF COVID-19 CASES AND THE PRESENT DIRECTION OF THE PROVINCE TO FURTHER COMBAT THE DISEASE

WHEREAS, Metro Manila and other neighboring provinces have already been placed under the stricter Alert Level 3 due to the spike of COVID-19 cases and the detection of cases of the highly infectious Omicron variant;

WHEREAS, the Province of Pangasinan is also experiencing an increase on the average number of COVID-19 cases for the past days;

WHEREAS, the Sangguniang Panlalawigan expresses grave concern over the sudden rise of COVID-19 cases as compared to the past few months when COVID-19 cases have already declined and normalcy has started to be back on the lives of everyone amid the public health crisis;

WHEREAS, the surge of COVID-19 cases was due to the increased mobility during the holiday season, the decreased compliance of minimum public health standards, and the detection of cases of the Omicron variant, which may lead to the possibility of local transmission in the country;


WHEREAS, the invitation is part of a series of Question Hours being conducted by the Sangguniang Panlalawigan in order to gather needed information for effective legislation;

RESOLVED, by the Sangguniang Panlalawigan in session assembled to invite, as they are hereby invited, the Provincial Health Officer, Provincial Disaster Risk Reduction and Management Officer and the Provincial Director of the Philippine National Police of the Provincial Inter-Agency Task Force (IATF); and the President of the League of Municipalities of the Philippines-Pangasinan Chapter to a Question Hour of the Sangguniang Panlalawigan during its Regular (Physical) Session to update the Body on the status of COVID-19 cases and the present direction of the Province to further combat the disease;
