APPROVING MUNICIPAL RESOLUTION NO. 90, S-2019 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 1 FOR CALENDAR YEAR 2019 OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Resolution No. 90, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991:

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Nicolas, Pangasinan has formulated the municipality's Supplemental Annual Investment Plan No. 1 for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Executive Committee Resolution No. 01, CY 2019 dated September 9, 2019. This was subsequently approved by their Sangguniang Bayan thru Municipal Resolution No. 90, S-2019 dated September 23, 2019;

WHEREAS, the Supplemental Annual Investment Plan No. 1 of the municipality with an investment requirement of P541,540.75 covers the salaries and other personal benefits of the newly-created position of Municipal Administrator;
