**RESOLUTION NO. 674-2019**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR  
CALENDAR YEAR 2019 OF SAN NICOLAS, PANGASINAN  
INVOLVING A TOTAL APPROPRIATION OF P541,540.75  
OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2019 involving total appropriations of **P541,540.75** which was approved on September 9, 2019 through Appropriation Ordinance No. 01;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget and the same showed substantial compliance with the provisions of the said Code and implementing circulars and other pertinent issuances;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order considering that it complied with the requirements both in form and substance;
