APPROVING MUNICIPAL RESOLUTION NO. 92, S-2019 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 2 FOR CALENDAR YEAR 2019 OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN”

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Resolution No. 92, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Nicolas, Pangasinan has formulated the municipality’s Supplemental Annual Investment Plan No. 2 for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 02, CY 2019 dated September 12, 2019. This was subsequently approved by their Sangguniang Bayan thru Municipal Resolution No. 92, S-2019 dated September 23, 2019;

WHEREAS, the Supplemental Annual Investment Plan No. 2 of the municipality covers the implementation of new development projects to be funded by the municipality’s Supplemental Budget No. 2. It also includes the projects proposed to be funded by national government agencies under LGSF program and congressional fund;

The amount of P8,679,922.00 will be funded by the Supplemental Budget No. 2 which was enacted through Appropriation Ordinance No. 3, S-2019 dated October 7, 2019 while the remaining amount of P205,299,000.00 is proposed to be funded by the national government agencies under the LGSF Program and Congressional Fund;
