WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Resolution No. 91, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Nicolas, Pangasinan through MDC Resolution No. 03, CY 2019 dated September 12, 2019 has endorsed for adoption the Supplemental Local Development Investment Plan for Calendar Year 2019 to the Sangguniang Bayan. The Sangguniang Bayan approved the Supplemental Local Development Investment Plan through Municipal Resolution No. 91, S-2019 dated September 23, 2019;

WHEREAS, the Supplemental Local Development Investment Plan of the municipality includes the new projects to be funded from Local Government Support Fund – Assistant to Municipalities (LGSF-AM) of the DILG and reversion of local funds as embodied in their Supplemental Budget No. 2;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
