APPROVING RESOLUTION NO. 20-029 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3 FOR CALENDAR YEAR 2020 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN”

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-029 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City, Pangasinan has prepared the city’s Supplemental Investment Program (SIP) No. 3 for CY 2020. This was endorsed by the Council thru CDC Resolution No. 03-20 (Series of 2020) dated May 14, 2020 to the Sangguniang Panlungsod for approval;

WHEREAS, the Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 20-029 dated June 1, 2020;

WHEREAS, said Supplemental Investment Program which has a total investment requirement of P14,457,478.90 covers the implementation of the First Tranche of Salary Increase of LGU personnel from January 2020 to December 2020 as per LBC No. 121 dated January 24, 2020, their uniform allowance and PhilHealth adjustment;
