**APPROVING RESOLUTION NO. 2019-068 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN, CALENDAR YEAR 2019, REQUIRING A TOTAL FUNDING OF EIGHT MILLION SIX HUNDRED ONE THOUSAND FIVE HUNDRED SIXTEEN PESOS (P8,601,516.00)”**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2019-068 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Sta. Barbara, Pangasinan has prepared the municipality’s Supplemental Annual Investment Program for CY 2019. This was endorsed by the Council thru MDC Resolution No. 2019-02 dated October 1, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2019-068 dated October 21, 2019;

**WHEREAS**, said Supplemental Annual Investment Program covers augmentation funds for Personal Services, MOOE and Capital Outlay and other development projects of the LGU;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
