## **PROVINCIAL RESOLUTION NO. 682-2021**

**DIRECTING THE PROVINCIAL HEALTH OFFICE TO FORMULATE A MANUAL OF COVID-19 PROTOCOLS AND GUIDELINES FOR THE FOURTEEN (14) PROVINCIAL GOVERNMENT HOSPITALS OF THE PROVINCE**

**WHEREAS**, the COVID-19 pandemic has placed frontline workers under immense and unprecedented pressure, putting their physical, mental and social well-being at risk;

**WHEREAS**, the Provincial Health Office plays a critical role in strictly enforcing or implementing COVID-19 protocols and guidelines for the fourteen (14) provincial government hospitals to further contain the spread of COVID-19 and to protect the health and safety of the people;

**WHEREAS**, there is a need for the Provincial Health Office to prepare a manual in order to guide the hospitals in handling and mitigating the effects of the COVID-19 pandemic;

**WHEREAS**, a manual anchored on national policies will provide strategies and guidelines to support the hospital management for effective and quality health care;

**WHEREAS**, it is the primordial concern of the Sangguniang Panlalawigan that the Province can immediately adopt and implement responses to COVID-19 situations through a manual of protocols and guidelines to be followed by the provincial government hospitals;

**WHEREAS**, the manual of COVID-19 protocols and guidelines shall be subject to the approval by the Sangguniang Panlalawigan;
