PROVINCIAL RESOLUTION NO. 683-2019

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE

WHEREAS, the Province of Pangasinan intends to purchase a motor vehicle which shall be turned over to the Integrated Small Fishpond Owners and Lessees (ISFOL) Multi-Purpose Cooperative located at Barangay Biec Duyao, Binmaley, Pangasinan, and which shall serve as a delivery vehicle for the production and marketing of processed bangus;

WHEREAS, the purchase of the said vehicle will be funded under the Philippine Rural Development Project or Investment for Rural Enterprises for Agricultural, Livestock and Fisheries Productivity (PRDP I-REAP) amounting to P1,206,000.00, with the following specifications:
