WHEREAS, one of the most respected local leaders of the Province of Pangasinan, Atty. Alfonso C. Bince, Jr., peacefully joined his Creator last August 10, 2021 at the age of 84;

WHEREAS, during his stint, former SP Member Bince had dutifully discharged his duties and functions in the Sangguniang Panlalawigan as Chairman of one of the most power-laden committees, the Blue Ribbon Committee, as he had led the august Body in the investigation of matters relating to malfeasance, misfeasance and non-feasance in office by officers and employees of the provincial government including the lower local government units;

WHEREAS, former SP Member Bince was also known to be a prolific Chairman of the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, who had tirelessly held committee hearings on its scheduled days and as evidenced by his remarkable accomplishments, the Sangguniang Panlalawigan had adopted and eventually approved numerous Committee Reports submitted by the said committee;

WHEREAS, former SP Member Bince, as Majority Floor Leader of the Sangguniang Panlalawigan, had responsibly fulfilled his powers, duties and functions to ensure the smooth disposal of the various items in the Order of Business or any matter brought before the Body;

WHEREAS, SP Member Bince had displayed the good quality of a dynamic local legislator, having passed and principally authored and co-authored several ordinances and resolutions that eventually benefited the Province, among of those measures are the Determination of the Exact Foundation Day of the Province of Pangasinan; Declaration of the Whole Province of Pangasinan and all within its Territorial Limits as Red Cross Emblem Misuse Free; Establishment of a Provincial Council of Senior Citizens and Persons with Disability in Pangasinan; and the Creation of the Pangasinan Historical and Cultural Commission;

WHEREAS, one of the highlights of his career was when he was awarded Special Recognition of the 2014 Asna Awards for being the role model and an inspiration to fellow *kabaleyans* and the Filipino people in their own field of expertise such as legislation;

WHEREAS, former SP Member Bince had left a precious legacy of love to his family, dedication and professionalism to his colleagues, kindness to his friends and relatives and admiration and respect to his *kabaleyans*;
