APPROVING RESOLUTION NO. 67, S-2020 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE REALIGNMENT OF SOME PROJECTS FUNDED UNDER TWENTY PERCENT (20%) MUNICIPAL DEVELOPMENT FUND FOR CY 2020 ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 67, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that on June 1, 2020, the Local Development Council of Asingan, Pangasinan thru MDC Resolution No. 2, S-2020 has endorsed to the Sangguniang Bayan for approval the realignment of some of the projects funded by the 20% development fund:

From:

1. Construction of box culvert near Agpaoa/LMMNHS - P350,000.00
2. Purchase of lot, construction of building for MRF
at Barangay Palaris - 300,000.00

To:

1. Construction of box culvert along Mayor's Blvd.,
Poblacion West - P350,000.00
2. Installation of Solar Streetlights at Barangay Palaris - 300,000.00

WHEREAS, also, on June 1, 2020, the Local Disaster Risk Reduction and Management Council thru MDRRMC Resolution No. 2, S-2020 has also realigned some of the programs/projects/activities included in the 2020 LDRRM Plan amounting to P3,838,708.18 to programs/projects to address emergency response to COVID-19 pandemic (P3,638,708.18) and purchase of additional equipment/gadgets for DRRM operations for WASAR (P200,000.00);

WHEREAS, the Sangguniang Bayan approved the said realignment of the 20% development fund and LDRRM projects thru Resolution No. 67, S-2020 dated June 8, 2020;

WHEREAS, the new projects to be funded by 20% development are consistent with DILG-DBM JMC No. 2017-1 dated February 22, 2017 while the projects to be funded by LDRRMF are also consistent with Local Budget Circular No. 124 dated March 26, 2020 and NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
