**APPROVING RESOLUTION NO. 431, S-2021 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) THRU MDC-EXECOM RESOLUTION NO. 001, SERIES OF 2021 WITH ITS CORRESPONDING PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) INCURRING A TOTAL AMOUNT OF TWO MILLION THREE HUNDRED FIFTY THOUSAND PESOS ONLY (P2,350,000.00)”**

**WHEREAS**, the Sangguniang Bayan of Bayambang, Pangasinan submitted its SB Resolution No. 431, S-2021 of the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject Supplemental AIP was endorsed to the Sangguniasng Bayan through MDC Executive Committee Resolution No. 001, Series of 2021 dated July 16, 2021;

**WHEREAS**, said Supplemental AIP with a total investment requirement of P2,350,000.00 covers the construction of Rural Health Unit VI in Barangay Mangayao, Bayambang;


