APPROVING RESOLUTION NO. 36, S-2021 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 3, CY 2021, OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its SB Resolution No. 36, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of Mapandan, Pangasinan prepared the municipality's Supplemental Annual Investment Plan No. 3, CY 2021 which was endorsed to the Sangguniang Bayan through MDC Resolution No. 03, S-2021 dated June 10, 2021;

WHEREAS, said Supplemental AIP with a total investment requirement of P1,061,591.64 covers augmentation fund for Personal Services and additional funds for COVID-19 related expenses of the LGU;

WHEREAS, funding support for the implementation of this SIP No. 3 is embodied in the Supplemental Budget No. 3, CY 2021 of the municipality, which was enacted by the Sangguniang Bayan on July 5, 2021 through Appropriation Ordinance No. 3, Series of 2021;


