APPROVING RESOLUTION NO. 37, S-2021 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 4 CY 2021 OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its SB Resolution No. 37, S-2021 o the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of Mapandan, Pangasinan prepared the municipality's Supplemental Annual Investment Plan No. 4, CY 2021 which was endorsed to the Sangguniang Bayan through MDC Resolution No. 05, S-2021 dated June 15, 2021;

WHEREAS, said Supplemental AIP with a total investment requirement of P78,985,000.00 covers the proposed Procurement of Cemetery Lot and Construction of Cemetery Extension 2 by the LGU;

WHEREAS, funding support for the implementation of this SIP No. 4 will be sourced from the proposed loan (from the Land Bank of the Philippines) of the LGU;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, of the Municipal Government of Mapandan, Pangasinan;
