**RESOLUTION NO. 696-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 06-2019 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE FOR THE OPERATION AND MANAGEMENT OF THE MUNICIPAL WAREHOUSE WITH MULTI-PURPOSE DRYING PAVEMENT (MPDP) AT MANAOAG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Municipal Ordinance No. 06-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 129, 154 and 447 (a) (3) (iii) of RA 7160;

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the legal requirement of publication pursuant to Section 188 of RA 7160;
