RESOLUTION NO. 697-2017

DECLARING MUNICIPAL ORDINANCE NO. 9-2017 OF SANGGUNIANG BAYAN OF URBIZTONDO. PANGASINAN, **ENTITLED** "AN **ORDINANCE** REGULATING PASSENGER CAPACITY THE TRICYCLES, JEEPNEYS AND OTHER MODES OF TRANSPORTATION WITHIN THE **TERRITORIAL JURISDICTION** OF THE MUNICIPALITY URBIZTONDO, **PANGASINAN** AND **PROVIDING** PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG **BAYAN TO ENACT**

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Municipal Ordinance No. 9-2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (2) (vi) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 and 511 of RA 7160;
