**APPROVING RESOLUTION NO. 21, S-2020 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED “APPROVING THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPAL SUPPLEMENTAL BUDGET NO. 1, S-2020 OF THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Resolution No. 21, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Quintin, Pangasinan has formulated and endorsed the municipality’s Supplemental Annual Investment Program (SAIP) No. 1 thru MDC Resolution No. 1, S-2020 dated March 3, 2020 to the Sangguniang Bayan on March 30, 2020 through Resolution No. 21, S-2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Annual Investment Program No. 1 with an investment requirement amounting to P4,243,577.46 covers the fund augmentation for the implementation of disaster risk reduction management programs/activities, personal services and maintenance and other operating expenses requirement of the various municipal government offices of the municipality;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


