DECLARING MUNICIPAL ORDINANCE NO. 19-007 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 3 (C) OF MUNICIPAL ORDINANCE NO. 10-005, OTHERWISE KNOWN AS "AN ORDINANCE TO ESTABLISH THE OFFICE FOR SENIOR CITIZENS AFFAIRS (OSCA) IN THE MUNICIPALITY OF LAOAC, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Municipal Ordinance No. 19-007 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (b) (2) (iv) and 447 (a) (5) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the posting requirement of Section 59 (b) of RA 7160;
