**RESOLUTION NO. 698-2021**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2021 OF SAN CARLOS CITY, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P331,999,913.00 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2021 involving total appropriations of P331,999,913.00 which was enacted on June 22, 2021 through Appropriation Ordinance No. 21-09;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the funding sources of the subject Supplemental Budget were determined in accordance to Section 321 of R.A. No. 7160 and Article 417 (a) of its Implementing Rules and Regulations (IRR) as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the total fund source available for supplemental appropriation (i.e) Proceeds from Loan from the Land Bank of the Philippines) will be made actually available as required under Article 417 (a) of the Implementing Rules and Regulations (IRR) of R.A. No. 7160, as amended by Administrative Order No. 47, and as contained in the Omnibus Term Loan Agreement between the LBP and the City Government of San Carlos;
3. That all programs, projects and activities to be implemented are in accordance with the CY 2021 Supplemental Investment Program of the City; and
4. That all procurements to be undertaken shall be subject to the provisions of R.A. No. 9184 (the Government Procurement Reform Act) and its IRR.


**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the city;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –


**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative In Its Entirety the Supplemental Budget No. 02 for Fiscal Year 2021 of San Carlos, Pangasinan;
