DECLARING **ORDINANCE OF** NO. 15, S-2021 SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN ENTITLED **ABOLISHING ORDINANCE POSITION ENGINEERING** ASSISTANT, **SALARY GRADE** DRAFTSMAN 1, SALARY GRADE 6 IN THE MUNICIPAL ORGANIZATIONAL STRUCTURE/STAFFING PATTERN OF THE MUNICIPALITY OF ASINGAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO **ENACT**
