PROVINCIAL RESOLUTION NO. 7-2019

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE UNIVERSITY OF THE PHILIPPINES ASIAN INSTITUTE OF TOURISM (UP AIT) FOR THE CONDUCT OF AN OUT-OF-CLASSROOM LEARNING ACTIVITY (OCLA) IN THE PROVINCE OF PANGASINAN

WHEREAS, the University of the Philippines Asian Institute of Tourism (UP AIT) has expressed its desire to partner with the Provincial Government of Pangasinan for the conduct of an Out-of-Classroom Learning Activity (OCLA) by its Tourism Development and Management Graduate students in Pangasinan;

WHEREAS, the OCLA activities will serve as a learning venue for students to be exposed to the tourism situation, gather data, and provide feedback and recommendations related to tourism development of the Province;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed with the Province of Pangasinan, represented by Honorable Governor, Amado I. Espino III; and the University of the Philippines, represented by Chancellor Michael L. Tan;


