**PROVINCIAL RESOLUTION NO. 7-2020**

**AUTHORIZING HONORABLE GOVERNOR AMADO I. ESPINO III TO DONATE FROM THE CALAMITY FUND FOR THE PROVINCES OF CAGAYAN, CAPIZ, EASTERN SAMAR AND THE CITY OF ROXAS FOR ITS RELIEF, RECOVERY AND REHABILITATION PURPOSES**

**WHEREAS**, in the latter part of 2019, the Provinces of Cagayan, Capiz, Eastern Samar and the City of Roxas were heavily devastated by Typhoons “Ramon” and “Ursula”, respectively;

**WHEREAS**, these areas had suffered the massive impact of the said typhoons which had caused billions of damages to agriculture and infrastructure to include school and commercial buildings, and houses, not to mention a number of injured casualties and loss of lives;

**WHEREAS**, the Provincial Government of Pangasinan has decided to extend financial assistance in the amount of P250,000.00 each to the Province of Capiz and Roxas City, P500,000.00 to the Province of Cagayan and P300,000.00 to the Province of Eastern Samar;

**WHEREAS**, the above-significant humanitarian endeavors of the Provincial Government of Pangasinan will greatly benefit thousands of families in the areas that were affected by the onslaught of Typhoons “Ramon” and “Ursula”;

**WHEREFORE**, on motion of SP Member Angel M. Baniqued, Jr. and all Members of the Sangguniang Panlalawigan, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, Honorable Governor Amado I. Espino III, to donate from the Calamity Fund for the Provinces of Cagayan, Capiz, Eastern Samar and the City of Roxas for its relief, recovery and rehabilitation purposes;


