RESOLUTION NO. 7-2021

APPROVING RESOLUTION NO. 2020-185 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 07 (SAIP NO. 07) OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO FOURTEEN MILLION THREE HUNDRED SEVENTY-EIGHT THOUSAND ONE HUNDRED TWENTY-EIGHT PESOS AND NINETY-SEVEN CENTAVOS (P14,378,128.97)”

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2020-185 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Alaminos City, Pangasinan had identified items in their Supplemental Investment Program No. 7 for CY 2020. This was endorsed to the Sangguniang Panlungsod for approval on October 2, 2020 by the City Development Council through CDC Executive Committee Resolution No. 07, S-2020;

WHEREAS, the Supplemental Investment Program No. 7 of the city covers the implementation of the proposed Mangrove Boardwalk at Bued Mangrove Park, which is proposed to be funded from the National Government specifically the Local Government Support Fund – Assistance to Cities in the amount of (P14,270,123.00) and from part of LGU Counterpart Fund from the LGU’s previously approved AIP 2020 in the amount of P108,005.97;


