**APPROVING RESOLUTION NO. 224, S-2019 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NUMBER 2 FOR CALENDAR YEAR 2019 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 224, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Asingan, Pangasinan has realigned some projects under the CY 2019 20% development fund amounting to P4,400,000.00 to new development projects. These are embodied in the municipality's Supplemental Annual Investment Plan No. 2 which was endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2, S-2019 dated August 14, 2019. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 224, S-2019 dated October 1, 2019;

**WHEREAS**, the identified development projects were based on DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


