PROVINCIAL RESOLUTION NO. 701-2020

EXPRESSING DEEPEST SYMPATHIES AND SINCEREST CONDOLENCES TO THE BEREAVED FAMILY OF THE LATE FORMER GOVERNOR AND ASSEMBLYMAN VICENTE D. MILLORA

WHEREAS, on July 9, 2020, the Provincial Government of Pangasinan lost one of its distinguished former political leaders with the passing of Atty. Vicente D. Millora at the age of 87 due to renal failure;

WHEREAS, the late former Atty. Vicente D. Millora had brought honor to the Province of Pangasinan as one of the Topnotchers in the 1957 Bar Examination and became one of the best and brilliant legal luminaries of the Province which also led him to become the National President of the Integrated Bar of the Philippines (IBP), the national organization of all lawyers in the country;

WHEREAS, the late former Atty. Vicente D. Millora, a respected Pangasinense leader from the Municipality of Infanta, also had a remarkable part in the history of Philippine politics during his service as the National Chairman of the Kilusang Bagong Lipunan (KBL) political party;

WHEREAS, during his political stint, the late former Atty. Vicente D. Millora had served as Provincial Governor of Pangasinan in an Acting capacity from September 16 to 30, 1971 during the transition period of two former provincial governors, and also fulfilled his duties and responsibilities as an Assemblyman from 1978 to 1984 representing the Province of Pangasinan in the defunct Batasang Pambansa;

WHEREAS, the late former Atty. Vicente D. Millora had lived a meaningful life worthy of emulation by every Pangasinense as he is survived by his wife Lilia and children: Judea, Monette, Mico, Mavi and Vvon;
