APPROVING RESOLUTION NO. 176, S-2017 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NUMBER 1 FOR CALENDAR YEAR 2017 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 176, Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Asingan, Pangasinan has formulated the municipality's Annual Investment Program No. 01 and endorsed thru MDC Executive Committee Resolution No. 1A, S-2017 dated September 27, 2017 to the Sangguniang Bayan for approval. This was subsequently approved by the Sangguniang Bayan through Resolution No. 176, S-2017 dated October 12, 2017. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Plan No. 1 of Asingan, Pangasinan which has an investment requirement of P5,172,993.10 covers fund augmentation for the maintenance and other operating expenses of some offices and implementation of development projects of the municipality;
