INVITING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO DELIVER HIS REPORT ON THE STATE OF THE PROVINCE BEFORE THE 10TH SANGGUNIANG PANLALAWIGAN ON ITS JULY 27, 2020 REGULAR (WEB-BASED/ONLINE) SESSION

WHEREAS, Section 465 (iii) of RA 7160, otherwise known as the Local Government Code of 1991, mandates the governor to annually brief the sangguniang panlalawigan on the state of the province and to present the provincial government's programs and policies for the new calendar year;

WHEREAS, it is imperative that the 10th Sangguniang Panlalawigan be apprised of Honorable Governor Amado I. 
