**PROVINCIAL RESOLUTION NO. 702-2021**

**AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, FOR THE PROCUREMENT OF THREE (3) UNITS OF MOTOR VEHICLE FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN**

**WHEREAS**, the Provincial Government of Pangasinan is in need of service and transport vehicles which shall be used for Disease Surveillance and Contact Tracing, and for Logistics and Laboratory Specimen for the Provincial Health Office;

**WHEREAS**, the Provincial Government of Pangasinan intends to procure three (3) units of motor vehicle for the said office with a total cost of P4,700,000.00, as herein specified, to wit:

**NOW, THEREFORE**, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


