PROVINCIAL RESOLUTION NO. 703-2019

APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2020

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the Revised Annual Investment Program (AIP) of the Province of Pangasinan for CY 2020 as endorsed by the Provincial Development Council thru PDC Resolution No. 03, S-2019;

WHEREAS, the AIP CY 2020 of the Province of Pangasinan was approved by the Sangguniang Panlalawigan on November 18, 2019 through Provincial Resolution No. 638-2019 with a total amount of P25,596,919,544.00 to finance the full implementation of the various programs, projects and activities of the Province;

WHEREAS, there is a need, however, to revise the said AIP to include the projects proposed to be funded by the Performance Challenge Fund (PCF), an award /incentive received by the Province from the Department of the Interior and Local Government for passing the 2019 Seal of Good Local Governance (SGLG), Improvement of Various Roads to be funded from the President's Social Fund (PSF) and Conditional Matching Grant to Provinces - Department of the Interior and Local Government (CMGP – DILG), various development projects for funding from the Energy Regulations 1-94 of the Department of Energy (DOE) and the programs, projects and activities funded from the Special Education Fund (SEF) 2020;

WHEREAS, after a careful study of the said Revised AIP, this august Body finds it to be in order;
