PROVINCIAL RESOLUTION NO. 703-2020

CONDEMNING THE BRUTAL SHOOTING TO DEATH OF MISS RENALYN S. AQUINO, AN EMPLOYEE OF THE PROVINCIAL GOVERNMENT OF PANGASINAN AND URGING THE PANGASINAN POLICE PROVINCIAL OFFICE AND OTHER LAW ENFORCEMENT AGENCIES TO FASTTRACK THE EARLY RESOLUTION OF THE CRIME

WHEREAS, in the early morning of July 7, 2020, Miss Renalyn S. Aquino of Binmaley, Pangasinan was shot to death at Barangay Cacaritan, San Carlos City, Pangasinan;

WHEREAS, the Sangguniang Panlalawigan is deeply saddened by the untimely death of Miss Renalyn S. Aquino as she is a hardworking Administrative Aide/Job Order employee of the Provincial Social Welfare and Development Office;

WHEREAS, as one of those in-charge of child development in her office, it is also saddening that Miss Renalyn S. Aquino's life was not only taken on that unfortunate day but also of her own child because she was pregnant;

WHEREAS, it is also shocking that the alleged person who took away their lives is her own boyfriend;

WHEREAS, her passing away is not only a great and irreparable loss to her family and relatives but also to the entire officialdom of Pangasinan especially the rank and file employees many of whom are her friends;

WHEREAS, the Sangguniang Panlalawigan is condemning in the strongest possible terms the untimely death of Miss Renalyn S. Aquino;


