RESOLUTION NO. 704-2021

DECLARING ORDINANCE NO. 158, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING THE FARE RATES OF TRICYCLES OPERATING WITHIN THE MUNICIPALITY OF BASISTA, PANGASINAN AND PRESCRIBING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 158, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (3) (vi) and Section 11 (F) of Executive Order No. 0033-2020 of the Province of Pangasinan;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;


