**PROVINCIAL RESOLUTION NO. 705-2017**

**INVITING THE CIVIL SERVICE COMMISSION, PROVINCIAL HEALTH OFFICER, PROVINCIAL LEGAL OFFICER, HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICER, ALL CHIEFS OF HOSPITALS OF THE PANGASINAN PROVINCIAL GOVERNMENT, DR. KARLO MARCO ORDUÑA AND DR. EMELITO V. RITUMALTA TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS DECEMBER 11, 2017 REGULAR SESSION TO APPRISE THE AUGUST BODY ON THE POLICIES GOVERNING PROVINCIAL GOVERNMENT EMPLOYEES WHO ENGAGE IN THE PRIVATE PRACTICE OF THEIR PROFESSION, IN AID OF LEGISLATION**

**WHEREAS**, in a Question Hour conducted by the Sangguniang Panlalawigan on its December 4, 2017 Regular Session, a query cropped up whether or not provincial government employees can engage in a private practice of their profession, particularly medical practitioners such as doctors and the like;

**WHEREAS**, Section 18 of the Omnibus Rules on Appointments and Other Personnel Actions of the Civil Service Commission provides that unless otherwise provided by law, no officer or employee shall engage directly or indirectly in any private business or profession without a written permission from the head of agency x x x;

**WHEREAS**, there is a need therefore to determine whether this Rule of the Civil Service Commission is being followed by the different Department Heads and Chiefs of Hospital of the Provincial Government of Pangasinan and their employees;

**WHEREAS**, Section 20 of the Internal Rules of Procedure of the Sangguniang Panlalawigan specifically provides that a “Question Hour is the period of time allotted for members of the Sanggunian to ask questions from invited resource persons coming from both the government and private sectors, usually heads of offices, technical men and prominent individuals primarily intended to seek information from the latter on certain matters that are of public interest”;

Ritumalta to a Question Hour of the Sangguniang Panlalawigan during its December 11, 2017 Regular Session to apprise the august Body on the policies governing provincial government employees who engage in the private practice of their profession, in aid of legislation;
