**WHEREAS**, the Sangguniang Bayan of Bugallon Pangasinan submitted its SB Resolution No. 39, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

**WHEREAS**, Local Development Council of Bugallon, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021 which was endorsed to the Sangguniang Bayan for approval on June 25, 2021 through MDC Resolution No. 03, S-2021;

**WHEREAS**, Supplemental AIP No. 2 of the municipality with an investment requirement of P1,600,000.00 covers the purchase of Emergency Response Vehicle proposed to be funded from the Local Government Support Fund (LGSF)-Other Financial Assistance to Local Government Units in the FY 2021 General Appropriation Act, Republic Act No. 11518;
