**RESOLUTION NO. 706-2017**

**DECLARING MUNICIPAL ORDINANCE NO. 4-2017 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, "AN ORDINANCE CREATING THE LOCAL DISASTER RISK REDUCTION MANAGEMENT OFFICE (LDRRMO) WITH LOCAL DISASTER RISK REDUCTION MANAGEMENT OFFICER III (LDRRMO III), SALARY GRADE 18 IN THE MUNICIPALITY OF MAPANDAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Municipal Ordinance No. 4-2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 76 and Section 447 (a) (1) (viii) of RA 7160;

**WHEREAS**, the salary grade allocation and qualifications and functions of the position created is in accordance with the provisions of NDRRMC-DILG-DBM-CSC Joint Memorandum Circular No. 2014-1 dated April 4, 2014;

**WHEREAS**, the salaries and other benefits of the position is appropriated in the CY 2017 Annual Budget of the municipality;


