**WHEREAS**, the Sangguniang Bayan of Bugallon Pangasinan submitted its SB Resolution No. 40, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;


