## **PROVINCIAL RESOLUTION NO. 709-2017**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO TERMS OF PARTNERSHIP WITH THE DEPARTMENT OF HEALTH REGIONAL OFFICE 1 FOR THE IMPLEMENTATION OF THE LOCAL INVESTMENT PLAN FOR HEALTH 2017-2019 THROUGH THE 2017 ANNUAL OPERATIONAL PLAN OF THE PROVINCE OF PANGASINAN**

**WHEREAS**, the Philippine Health Agenda (PHA) 2016-2022 has been released by the present administration, through the Department of Health (DOH), with the theme “All for Health Towards Health for All” which guarantees financial protection, better health outcomes and responsiveness for all Filipinos;

**WHEREAS**, the Local Investment Plan for Health (LIPH) 2017-2019 of the Province shall serve as a vehicle to carry out the objectives of the PHA in order to provide the best health benefits and services for the people;

**WHEREAS**, through the LIPH, the Province of Pangasinan shall receive financial allocation support from DOH and other sectors for the implementation of its approved Annual Operational Plan for 2017;

**WHEREAS**, the LIPH guarantees the implementation of programs/projects/activities in the Province of Pangasinan, together with its component LGUs, toward achieving a more responsive health system and equitable health care financing;
