WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its SB Resolution No. 213-08022021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

WHEREAS, Local Development Council of Pozorrubio, Pangasinan has formulated and endorsed the municipality's Third Supplemental Investment Program through MDC Resolution No. 03, S-2021 dated July 1, 2021;

WHEREAS, Third Supplemental AIP with an investment requirement amounting to P14,528,316.32 covers the implementation of development projects and fund augmentation for the disaster risk reduction and management activities, personal services, maintenance and other operating expenses and capital outlay of some offices of the municipality;
