APPROVING RESOLUTION NO. 438, S-2019-22 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3 OF THE CITY OF URDANETA FOR CY 2021 IN THE AMOUNT OF SIXTY-TWO MILLION TWO HUNDRED SEVENTY-SEVEN THOUSAND FOUR HUNDRED FORTY-ONE PESOS AND FORTY-SIX CENTAVOS ONLY (P62,277,441.46)"

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its SB Resolution No. 438, S-2019-22 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

WHEREAS, Local Development Council of Urdaneta, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2021 which was endorsed to the Sangguniang Panlungsod for approval on June 10, 2021 through LDC Resolution No. 2, S-2021;

WHEREAS, SAIP No. 3 of the city covers fund augmentation for Maintenance and Other Operating Expenses and Capital. Outlay of some city government offices and implementation of various development programs/projects/activities amounting to Php47,277,441.46 as embodied in their Supplemental Budget No. 3, CY 2021 which was pass and approved by their Sangguniang Panlungsod on June 22, 2021 through Ordinance No. 51, Series of 2019-22;
