RESOLUTION NO. 715-2017

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2017 OF BAYAMBANG, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P60,923,367.25 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its supplemental Budget No. 1 for Calendar Year 2017 involving total appropriations of **P60,923,367.25** which was approved on October 2, 2017 through Appropriation Ordinance No. 03, S-2017;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

 All programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2017 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;

- 2. All procurements to be undertaken shall strictly be subject to the pertinent provisions of RA 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
- 3. The purchase of Motor Vehicle/s shall be subject to the provisions of Budget Circular No. 2017-1 of the Department of Budget dated April 26, 2017 re "Revised Guidelines on the Acquisition and Use of Government Motor Vehicles"; and
- 4. The disbursement of loan proceeds shall be in accordance with the loan agreement between the Municipality of Bayambang and the East West Banking Corporation.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order considering that it complied with the requirements both in form and substance;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Angel M. Baniqued, Jr. and Generoso D. Tulagan, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 1 for Calendar Year 2017 of Bayambang, Pangasinan as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang;
