APPROVING RESOLUTION NO. 2017-53 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "TO ADOPT THE DETAILS OF THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 CY 2017, AS EMBODIED IN THE MDC RESOLUTION NUMBER 8, SERIES OF 2017 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF BOLINAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Resolution No. 2017-53 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bolinao, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2017 with a total investment requirement of P6,441,724.28. This was endorsed to the Sangguniang Bayan for approval on October 6, 2017 thru MDC Resolution No. 8, S-2017 and was favorably acted upon by the Sangguniang Bayan on October 10, 2017 thru SB Resolution No. 2017-53;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
